Description: ON YOUR VEHICLE, IT MAY BE POSSIBLE THAT TERMINALS IN AN INLINE CONNECTOR WERE MISALIGNED DURING ASSEMBLY, WHICH MAY RESULT IN A LOSS OF FUNCTION IN BOTH LEFT AND RIGHT REAR TAIL LAMPS. IN THIS CONDITION, YOUR VEHICLE WILL EXHIBIT A RAPIDLY FLASHING TURN SIGNAL INDICATOR ON THE INSTRUMENT CLUSTER WHEN YOUR TURN SIGNAL IS USED.

YOUR REAR TAIL LAMPS MAY NOT ILLUMINATE. THIS INCLUDES THE STOP, TURN, REAR POSITION, AND BACKUP LAMPS, WHICH CAN REDUCE THE VEHICLE'S VISIBILITY AND MAY NOT FULLY ALERT OTHER DRIVERS THAT THE VEHICLE IS BRAKING, TURNING, OR REVERSING, INCREASING THE RISK OF CRASH. Damage Severity

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

New Owner Reported

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico. Dealers sometimes opt to take ownership of a vehicle and are required to in the following states: Maine, Massachusetts, New Jersey, Ohio, Oklahoma, Pennsylvania and South Dakota. Please consider this as you review a vehicle's estimated ownership history.

Rebuilt/Reconstructed Title

A Rebuilt/Reconstructed vehicle is a salvage vehicle that has been repaired and restored to operation. These vehicles are often severely damaged before they are rebuilt and refurbished parts are typically used during

reconstruction. In most states, an inspection of the vehicle is required before the vehicle is allowed to return to the road.

Salvage Auction Record

Most vehicles sold at Salvage auctions were declared totaled by insurance companies. Most of these vehicles have sustained significant damage but there are some exceptions. For instance, recovered stolen vehicles are often declared a total loss regardless of the actual damage. Rebuilders and Recyclers purchase these vehicles at auction with intentions to rebuild them or dismantle them for parts.

Salvage Title

A Salvage Title is issued on a vehicle damaged to the extent that the cost of repairing the vehicle exceeds approximately 75% of its pre-damage value. This damage threshold may vary by state. Some states treat Junk titles the same as Salvage but the majority use this title to indicate that a vehicle is not road worthy and cannot be titled again in that state. The following eleven states also use Salvage titles to identify stolen vehicles - AZ, FL, GA, IL, MD, MN, NJ, NM, NY, OK and OR.

Title Issued

A state issues a title to provide a vehicle owner with proof of ownership. Each title has a unique number. Each title or registration record on a CARFAX report does not necessarily indicate a change in ownership. In Canada, a registration and bill of sale are used as proof of ownership.

Total Loss Vehicle

An insurance or fleet company declares a vehicle a total loss when a claim exceeds approximately 75% of its predamage value or if the vehicle is stolen and not recovered. This damage threshold varies by company. These companies typically take possession and obtain the title. Not all total loss vehicles result in a DMV-reported branded title. This may occur when an insurance company's definition of a total loss is different than the state DMV's definition for a branded title or when the owner of the vehicle is a self-insured company, like a fleet or rental company.
